ZERO TOLERANCE ALCOHOL POLICY

- (1) In accordance with BC's Liquor Control and Licensing Act, section 40 (1)*, alcohol is not permitted to be consumed by players, coaches, managers or scorekeepers on or near fields where the Mabel League holds playing permits.

*As of Apr 2009: Liquor Control and Licensing Act, section 40 "Consumption of liquor in public" subsection (1):

Except for liquor purchased and consumed in accordance with a licence that permits consumption in a public place, a person must not consume liquor in a public place.

- (2) A breach of the Zero-Tolerance Alcohol Policy will be dealt with under Part 2, Section 2 (4) of the Mabel League Constitution and By-Laws.

Mabel League Constitution and By-Laws: Part 2, Section 2(4):

The Executive may expel, suspend or otherwise discipline any Member who in their opinion is guilty of conduct which is improper or unbecoming for a Member of the Society, or is likely to endanger the interest or reputation of the Society or is a breach of these Bylaws, but the Executive may not expel, suspend or otherwise discipline any Member until that Member has been notified of the proposed action and has been given an opportunity to be heard by the Executive.

ZERO TOLERANCE VIOLENCE POLICY

In an effort to provide participants with a healthy, safe and fun environment that encourages fair play, teamwork and sportsmanship, the Mabel League holds a Zero Tolerance policy toward Violence for all members (including players, coaches, managers and scorekeepers), umpires and spectators. This policy requires all persons to maintain a sportsmanlike and positive atmosphere before, during and after all Mabel League sanctioned events.

Violence includes, but is not limited to the following behaviours:

- verbal assaults;
- threats and/or attempts to intimidate;
- throwing of articles in a deliberate or aggressive manner;
- aggressive approaches to another individual or group;
- physical striking of another individual;
- intentional and/or unnecessary violence within game play
- attempts to provoke or entice violence in others;
- derogatory slurs;
- unsportsmanlike behavior toward any person.

Any member or spectator participating in Violence or other inappropriate behavior may be ejected from the game at the sole discretion of the umpire.

Depending on the extent and severity of the behaviour, and/or repeat incidences of the behaviour, a league report will be filed and that member may be deemed not in good standing of the league association after review by the Mabel League Executive.
